City Heights Update

On Saturday, April 23, 2022, the Housing Authority of Covington and the Kentucky Human Rights Commission cosponsored a Relocation Resource Fair in City Heights from 11:00am-2:00pm. Thirteen local agencies participated to share their program information in support of residents' relocation efforts.

Three partners shared information on homeownership opportunities. Each offers various homebuyer supports to applicants, either directly or through other partner agencies. These supports include, but are not limited to: homebuyer education, financial literacy and credit counseling, and low interest or interest-free down payment assistance.

While homeownership is not for everyone, it can be a viable option over renting for those who are employed. Different programs will have different eligibility criteria. Please contact the agencies listed below for more information.
